Jennifer Brown made a motion for approved treasury report and proposed expenses and Anne Childress seconded it. All members showed approval with a green check motion was passed.

So the 2014/2015 Georgia Cyber Academy Parent-Teacher Student Organization executive board Jen Brown as president, Anthea Carter is vice president. , Shirley Lester as secretary, Anne Hendricks Childress as vice secretary, Nicki Turner as treasurer and Andrea Smith has vice treasurer.

Fundraising committee report: Angie Spies reports that the spring fundraiser has sold \$1600 worth of merchandise we get 40% of that total which comes to \$640. Still have one more day of fundraiser left.
